

# **The Frankenshot: Using the Law to Chase Those Responsible for Harming the American People: A Special Interview With Francis A. Boyle**

## **By Dr. Joseph Mercola**

### **Dr. Joseph Mercola:**

Welcome, everyone, this is Dr. Mercola, helping you take control of your health and today, we are pleased to have a repeat guest, Francis Boyle, who has been on twice previously. Most notably at the beginning of all this craziness when we interviewed him for insights on the origins of the SARS-CoV-2 virus and the fact that it was likely not derived from nature but was engineered in a lab. At the time, any mention of that would get you thrown in jail, at least social media jail, or de-platformed, and of course since earlier this year that has become known as the reality of what has happened and perhaps Dr. Boyle's investigations have been vindicated. So he's back with us to explore some of the ways and the strategies he's come up with, with respect to how to prosecute these individuals for what they're doing because they're in complete, direct violation of legislation or treaties that he's written, actually, probably close to 50 years ago now or 40 years ago. So he's going to enlighten us and give us more information about the details of that process. So welcome and thank you for joining us today.

### **Francis A. Boyle:**

Well, thank you very much for having me on, Dr. Mercola. And yes-

### **Dr. Joseph Mercola:**

[crosstalk 00:01:36] Oh, if I can interrupt. If I can interrupt, I'm sorry. I forgot to give your credentials. You're an attorney who graduated magna cum laude from Harvard Law School, went to the University of Chicago in my neck of the woods when I was around there at that time, and now, are back at the University of Illinois where you're a full professor of law and have been for quite a number of decades. And obviously, a pioneer in exposing the fraud of the origin of the coronavirus. So I'm sorry for the interruption, but [crosstalk 00:02:12] I forgot to enlighten people.

### **Francis A. Boyle:**

-No, that's fine and not to toot my own horn, but yes, I did draft the U.S. domestic implementing legislation for the Biological Weapons Convention, known as the Biological Warfare Anti-Terrorism Act of 1989 that was passed unanimously by both houses of the United States Congress and signed into law by President George Bush Sr. with the approval of the United States Department of Justice. And I did want to thank you profoundly for being one of the first media people to let me appear on your program to point out that COVID-19 was in fact an offense of biological warfare, a weapon with gain-of-function properties that was existentially dangerous when, as you know, the entire scientific establishment here in America was discounting that and saying that that was nothing more than a conspiracy theory and fake news. So I want to thank you for that. I thought it was a public service, the two previous interviews we did.

### **Dr. Joseph Mercola:**

Yeah, well and this is taking it a step further because obviously there's enormous crimes against humanity that have been committed that will likely exceed the atrocities of World War II because of what's-

### **Francis A. Boyle:**

You're right about that. Yes.

**Dr. Joseph Mercola:**

-what's been implemented.

**Francis A. Boyle:**

We can go through that in more detail as the interview progresses, yes.

**Dr. Joseph Mercola:**

Okay. So I think in September, you gave a presentation to some group and outlined a process where a strategy, not so much a process, but a strategy that could be implemented get the treaty that you wrote enforced because there is no way in this world that the federal authorities will ever, ever seek to enforce that treaty because they are totally captured. So you have a strategy that focuses more on local attorney generals, secretary generals. So can you summarize what that plan is?

**Francis A. Boyle:**

Right. And you are correct, all federal authorities are in the tank here with Biden and what I call these "Frankenshots," there's no other word for them. Years ago when I did work with the Council for Responsible Genetics, they were against biological weapons, I handled that and they had another key component against genetically modified organisms for foods, which everyone called "Frankenfoods." So I thought it would be appropriate to call these Frankenshots and not dignify them with the word vaccines, wherever you stand on vaccines. But you're right, all the federal authorities are in the tank here for the Frankenshots. In my opinion, that would also include federal judges. They are part of the federal system. I've been appearing before federal judges since 1982 on matters of courage, integrity, and principles. I can only think of one federal judge that gave us a fair trial. So we can't rely upon federal judges to pull our chestnuts out of the fire.

**Francis A. Boyle:**

And that then gets me to the 10th Amendment to the United States Constitution, the powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people. So we, in my opinion, cannot rely on federal judges to pull our chestnuts out of the fire, they're not going to do it. So we have to do this ourselves. So my proposal is this, that we have to, the American people at a state, local, community basis, have to go to our local prosecutors, that is state's attorneys, district attorneys, county attorneys, attorney generals, any local prosecutor. And the last I read there were well over 400 of these in the country. These local prosecutors are not part of the federal system. They have been empowered by the 10th Amendment to the United States Constitution.

**Francis A. Boyle:**

They are democratically elected by the people of their community. Federal judges are not elected by anyone. They're appointed by the President and once they're on their bench with life tenure and they can only be removed by impeachment, which is almost impossible and their salaries cannot be reduced, they're like God Almighty up there sitting on these federal benches. Not so state, local prosecutors, they're accountable to the people of the community. So what I am recommending is two steps. One, on the Frankenshots and another on the COVID pandemic. And let me start with the COVID pandemic first, the origins of the COVID pandemic.

**Francis A. Boyle:**

I would recommend that people organize together in your community and go to all of your local prosecutors, you know who they are, you voted for them, and demand that they convene a grand jury to seek the indictment of those for murder and conspiracy to commit murder for those people who were responsible for COVID-19. Now, Doctor, we've discussed this before, that article "SARS-like Cluster of Circulating Bat Coronavirus Pose Threat for Human Emergence," and that is the smoking gun on who is behind COVID-19. Who's on that contract? [Vineet] Menachery from the University of North Carolina, they're BSL-3, other people there from the University of North Carolina, including [Ralph] Baric. We also know that [Peter] Daszak was working with Baric on this entire project. A person from the Food and Drug Administration. Let me repeat that, Doctor. A person from the Food and Drug Administration, the Food and Drug Administration was involved in the research, development, and testing of COVID-19. These are the exact same people, the Food and Drug Administration, who are authorizing all of these Frankenshots, including last week for kids from 5 to 12. Trick or treat on America's youth.

**Francis A. Boyle:**

So they developed this biological warfare weapon and now they're approving all the Frankenshots. This is a one-two punch here against the American people. I'm not going to go through the foreign institutes involved in this, but it also says on this exact same project, the Harvard Medical School. I repeat that, the Harvard Medical School. Well, I'm a triple alumnus of Harvard Medical School and there is Harvard Medical School involved in the research, development, and testing of COVID-19 and offensive biological warfare weapon. We also know that Harvard was a sponsoring institution of the Wuhan BSL 4. That Wuhan BSL-4 is China's Fort Detrick. There's no doubt about it in my mind. Okay?

**Francis A. Boyle:**

And who is the current Director of the CDC (Centers for Disease Control and Prevention)? Biden's Director of the CDC? [Rochelle] Walensky. She is from the Harvard Medical School. You can't believe anything the CDC is telling you or Walensky is telling you, they're bald-faced liars and they always have been. Indeed, the CDC has been involved in research, development and testing of offensive biological warfare weapons, at least I've been able to determine, from official government documents, from the early 1980s. Okay? And they then, the CDC and Walensky, then have recently ratified the FDA (Food and Drug Administration) approval of the Frankenshots. Then in addition of course, on the SARS project here is Zhengli Shi, the bat queen from the Wuhan Institute of Virology, Chinese Fort Detrick. It says it right on there. They're all working in cahoots with each other.

**Francis A. Boyle:**

And also then, if you read the footnotes of this article, they are working with our own Fort Detrick, okay? So they're all in cahoots. You have Chinese Fort Detrick, you have our Fort Detrick, you have the UNC (University of North Carolina) BSL-3, Harvard Medical School all working together to research, develop and test, also with the Wuhan BSL-4, COVID-19. Who has funded all this? The contract makes it quite clear, it was funded by the National Institutes of Health, then directed by Francis Collins. He knew full well what was going on here. He was over there cooperating with China and the Wuhan BSL-4. And also, NIAID, National Institutes for Allergy and Infectious Diseases, Tony Fauci. He's on here too. They were involved in this.

**Francis A. Boyle:**

Indeed, it was the Reagan Administration that first got involved in the abuse of DNA genetic engineering for biological warfare weapons purposes that first compelled the Council for Responsible Genetics and me to draft and lobby through Congress my Biological Weapons Anti-Terrorism Act of 1989, approved unanimously by both houses of Congress and signed into law by Bush Sr., with the approval of the Department of Justice. And right at that time, Reagan, under the influence of his neo-conservatives who

believe in biological warfare and ethnic-specific biological warfare put Tony Fauci in charge of this entire Nazi program. And about 95% of all this Nazi-type biological warfare research has been done by, under the auspices of Tony Fauci.

**Francis A. Boyle:**

So what I am recommending here then is for everyone to go to their local prosecutors, have them convene a grand jury, and present the case for murder and conspiracy to commit murder for everyone on this contract and including Daszak, that's been reported he's been working in cahoots with all of them on this. Now, I was originally hired here in 1978 to teach criminal law and I taught criminal law for seven or eight years until I moved over to teach international human rights law, but I still do criminal work, both prosecution and defense. And Anglo-American common law has a definition for murder that is applicable in all states of the United States except Louisiana that has the Napoleonic Civil Code and I haven't studied that. But all the other states have the Anglo-American common law definition of murder and that definition is the unlawful killing of a human being with malice of forethought.

**Francis A. Boyle:**

All right, let's parse that down. Unlawful, all right, all these individuals I just mentioned here on this contracted, including Daszak, were involved in research, development, testing and stockpiling of biological warfare weapons in clear cut violation of my Biological Weapons Anti-Terrorism Act of 1989. Killing of human beings, Doctor, you're free to disagree with me in good faith, we've had good faith disagreements before, but I think the number of Americans who have been killed, murdered by COVID-19 is well over a million. This is just a substantial undercount as far as I can tell. [crosstalk 00:16:28].

**Dr. Joseph Mercola:**

If I could just jump in.

**Francis A. Boyle:**

Yes, go ahead.

**Dr. Joseph Mercola:**

If I could jump in, I do think it's over a million, but that would be if you included those who have been killed by the what you call Frankenshot, but I think Vladimir Zelenko more accurately calls it the "kill shot," makes it simpler and easier to remember because the kill shots clearly are two, three, four, even 500,000 people have died from it in the United States alone. The reason that you have to be careful about the COVID-19 deaths calculated by the CDC is that they've perverted the definition of a death. So you could have a positive PCR test, and have terminal cancer, die in a motorcycle accident and you'd still be counted as a COVID death, which is not true. You died with COVID, not from it. So anyway, it's a moot issue. I think you're-

**Francis A. Boyle:**

[crosstalk 00:17:17] Well, I was dealing with figures compiled and reported by the Financial Times on excess deaths from COVID, but-

**Dr. Joseph Mercola:**

[crosstalk 00:17:27] isn't the Financial Times a U.K.?

**Francis A. Boyle:**

U.K. I subscribe to them to get a foreign perspective.

**Dr. Joseph Mercola:**

[crosstalk 00:17:35] They have stats on-

**Francis A. Boyle:**

[crosstalk 00:17:36] Let me – we can disagree about the numbers, but in any-

**Dr. Joseph Mercola:**

[crosstalk 00:17:40] Well, it's a moot issue. It's still over a million. [crosstalk 00:17:42].

**Francis A. Boyle:**

It's a moot issue, right.

**Dr. Joseph Mercola:**

Yeah.

**Francis A. Boyle:**

And then with malice of forethought. Malice of forethought is a legal term of art. It would take me three, four, five different class sessions to go through it all and I'm not going to do that here. But one element of malice of forethought is reckless endangerment of human beings and clearly they knew, if you read the contracts and the studies, they knew, all these people that I mentioned to you, including Fauci and Collins, who by the way just resigned because the proverbial [inaudible 00:18:31] was about to hit the fan on Collins. Pardon my French. But they knew that this gain-of-function work was existentially dangerous and they did it anyway. Okay? And clearly that constitutes reckless endangerment of human beings, malice of forethought.

**Francis A. Boyle:**

And so you have all the elements there for murder and then conspiracy to commit murder. In common law, conspiracy is two people getting together to agree to do an unlawful act, violation of my statute, or a lawful act by illegal means. So I think we have all these people at least for murder and conspiracy to commit murder and my advice is that if you have lost a loved one or a friend living in the territorial jurisdiction of any of these local prosecutors, they would have jurisdiction to convene a grand jury and seek indictments for murder and conspiracy to commit murder against all of these people. Now, let me move on to the Frankenshot.

**Dr. Joseph Mercola:**

Well, before you move on-

**Francis A. Boyle:**

I'm sorry. Yes. Go ahead.

**Dr. Joseph Mercola:**

-who would you target as the result of the grand jury indictments? Would it be – Fauci, for sure, Peter Daszak, probably Francis Collins, but are there any other specifics, because you can't just generically have this indictment. It has to be the specific individuals.

**Francis A. Boyle:**

That's correct and they've got 12 different people listed by name on this contract at the UNC BSL-3. You are correct.

**Dr. Joseph Mercola:**

Okay, so Ralph Baric.

**Francis A. Boyle:**

So I would go after all of them, including the bat queen, for murder and conspiracy.

**Dr. Joseph Mercola:**

[crosstalk 00:20:30] But she's a Chinese citizen.

**Francis A. Boyle:**

Right. [crosstalk 00:20:32] That's correct, but she did this here in the United States so we would have jurisdiction over her. Remember, they had her working at the UNC BSL-3 along with Fort Detrick. Now, there are no names for Fort Detrick so I can't really say who that would be, but you have all these names listed on the-

**Dr. Joseph Mercola:**

Okay, so whoever's listed on that contract.

**Francis A. Boyle:**

That's right. And Francis Collins, and Tony Fauci, and Peter Daszak, right? Those would be the people I'd go after to start.

**Dr. Joseph Mercola:**

Okay. All right, good.

**Francis A. Boyle:**

Now, let's get on to the Frankenshots and again, with all due respect, I prefer Frankenshots because they're using DNA genetic engineering of the messenger RNA, et cetera. But call them what you want, yes they are kill shots. So I'm just-

**Dr. Joseph Mercola:**

[crosstalk 00:21:28] It's the end result.

**Francis A. Boyle:**

[crosstalk 00:21:30] analogize it. People are aware of what Frankenfoods are.

**Dr. Joseph Mercola:**

Yeah.

**Francis A. Boyle:**

And we were opposed to Frankenfoods. I did not handle that legal work for the Council of Responsible Genetics because I was busy doing biological warfare work, but I was fully aware of all the work and I'm sure you were. That the Council for Responsible-

**Dr. Joseph Mercola:**

[crosstalk 00:21:49] Yeah, and for those that don't know, you were real ahead of the game because that work that you refer to was the absolute very first effort to put a halt and a block on this effort. That was the first professional effort.

**Francis A. Boyle:**

That's correct.

**Dr. Joseph Mercola:**

Nothing was done before that. That was in the '80s.

**Francis A. Boyle:**

That's correct.

**Dr. Joseph Mercola:**

I mean, the real work to get done-

**Francis A. Boyle:**

Starting 1983, Doctor. Yes.

**Dr. Joseph Mercola:**

Yeah. Yeah. [crosstalk 00:22:12] They were the absolute first group.

**Francis A. Boyle:**

Back then they were called the committee.

**Dr. Joseph Mercola:**

They were the pioneers.

**Francis A. Boyle:**

And I point out, they had some of the top life scientists in the world involved in the council. Harvard, MIT, Sloan Kettering, elsewhere. They lined up some of the top people in the world to oppose GMO food. They did the pioneering work. I'm sure you have probably in your library our newsletter called GeneWatch and so I would read that to find out what they were doing there, as well as any biological warfare work that I was doing as well. Sure.

**Dr. Joseph Mercola:**

Mm-hmm (affirmative). So-

**Francis A. Boyle:**

All right, now to deal with the Frankenshots. Unlawful killing of human beings with malice of forethought. Okay, unlawful, here we have a blatant, obvious violation of the Nuremberg Code on

Medical Experimentation, which is a Nuremberg crime that the United States government prosecuted Nazi doctors at Nuremberg and executed some of them. Indeed, you can read all of this in the Nuremberg medical doctor's judgment. Indeed, I heard from some doctors say, "Well, this really destroys your credibility to say that the United States government actually executed doctors." And I said, "You know, you never studied the Nuremberg medical doctor's case, the list of executed doctors is right there at the end." That's correct. And what we're seeing now with these Frankenshots for children, this is Dr. Mengele at Auschwitz all over again. That's where this Nuremberg Code on Medical Experimentation came from.

**Francis A. Boyle:**

Second, unlawful killing of human beings is the Nuremberg Charter judgment and principles. The charter, 1945, the judgment, 1946, and the principles of 1950, defining a crime against humanity. You pointed this out, a crime against humanity, yes that is correct. In the Nuremberg Charter judgment and principles, a crime against humanity is defined in part as murder, extermination, or other inhumane acts committed against a civilian population. That's what's going on right now against the American population. And Doctor, I should point out that provision in there, crime against humanity, was put in there to deal with precisely and exactly with the Nazi persecution of German-Jewish citizens. Okay?

**Francis A. Boyle:**

That's exactly what the Biden Administration today is doing to all American citizens, a crime against humanity as defined by the Nuremberg Charter judgment and principles. And again, we executed Nazi leaders at Nuremberg for committing crimes against humanity in conjunction with either crimes against peace or war crimes. But since that time, the connection there, they have to actually be in war has been limited. So crimes against humanity stand on their own. You can also read this in the Rome Statute for the International Criminal Court. Now, the United States government is not a party to the Rome Statute, but it simply reflects customary international criminal law today. All right, killing-

**Dr. Joseph Mercola:**

[crosstalk 00:26:08].

**Francis A. Boyle:**

- I'm sorry, go ahead. I'm sorry, you had a question. Go ahead.

**Dr. Joseph Mercola:**

Yeah, before we go on, I just want to wrap this point up because I'm curious, to the best of your knowledge if any individuals have ever been prosecuted or even convicted under the Nuremberg Charter, even the Helsinki Act or Accord?

**Francis A. Boyle:**

I did defend the Dr. Yolanda Huet-Vaughn, who refused to give the Frankenshots in Gulf War I for anthrax and botulin. And I came to her defense in February 1991, she was court martialed for this facing five years. And I helped defend her, I was part of the team and the expert on the Nuremberg Code of Medical Experimentation and also on Helsinki. And we argued that quite extensively in her [inaudible 00:27:12] court martial down out Fort Leonard Wood, in which I appeared before two satellite dishes saying that Bush Sr., Dick Cheney, the Secretary of Defense, Colin Powell, who's now been adulated all over the country, and Norman Schwarzkopf, General Norman Schwarzkopf have perpetrated a Nuremberg crime on our own troops for violating the Nuremberg Code on Medical Experimentation.

**Francis A. Boyle:**



I was told that went out nationwide, made it all the way to the White House by a lawyer who was there, and they were all shaken up. Later on, Senator Jay Rockefeller held hearings on this and he also accused Bush and the rest of them of committing a Nuremberg crime on our own troops. Now, at the time we didn't know what the consequences would be, but within the next two years it came to my attention that the Gulf War Sickness, that out of about, and the Pentagon still lies about these figures, out of about 500,000 U.S. troops inoculated with these two Frankenshots, 11,000 were killed and 100,000 were disabled, and those were healthy young men and women in U.S. Armed Forces.

**Francis A. Boyle:**

Well, you can extrapolate from there, Doctor, what's going to happen with these current Frankenshots. They're even more dangerous than the Frankenshots during Gulf War one. The figures are mind blowing if you just sit down and that is a floor, it is not a ceiling because the current Frankenshots are far more dangerous than what [crosstalk 00:29:22].

**Dr. Joseph Mercola:**

That's a whole separate discussion, but just to clear it up, so you I guess used this as part of your defense for that soldier who was being prosecuted, the Nuremberg Code-

**Francis A. Boyle:**

He was a medical doctor.

**Dr. Joseph Mercola:**

I get that, but from the best of your knowledge that was more of a defense, but no one's been specifically prosecuted under Nuremberg or Helsinki since those treaties were enacted, subsequent to the actual Nuremberg Trial itself.

**Francis A. Boyle:**

Not that I'm aware of, but they are still valid and binding, and on the books.

**Dr. Joseph Mercola:**

Yeah, I know, but it's just curious [crosstalk 00:29:56]. Seventy years later, no one's been prosecuted under this treaty, no one.

**Francis A. Boyle:**

Not that I am aware of.

**Dr. Joseph Mercola:**

Yeah, that's just-

**Francis A. Boyle:**

But the Captain Doctor Huet-Vaughn case, it is one case I know where these arguments were made. There was another case I was not involved in preventing mandatory anthrax shots on U.S. troops and a federal district judge did stop that, but that's about it that I am aware of. No one's been prosecuted. But let me go back then to the Frankenshots, the third element, malice of forethought. All right, and here one other element of malice of forethought is an intention to inflict death or grievous bodily harm. All right, well, let's give these people the benefit of the doubt, say, "Well, we didn't intend to kill anyone with our

Frankenshot." Well, okay, but you did intend to inflict grievous bodily harm on human beings and it killed human beings, large numbers of them.

**Francis A. Boyle:**

Again, we do not have an exact estimate and it could be as you said, several hundred thousand, we just don't know. But they clearly intended and knew that this would inflict grievous bodily harm on human beings. Just look at what they've already conceded and reported the adverse effects would be, the list is astounding. So they knew this and they did it anyway. So my position here then would be, if you believe you have lost a loved one or a friend as a result of the Frankenshots, again, go into your local prosecutor and ask your local prosecutor to pursue before a grand jury indictments for murder and conspiracy to commit murder against the chief executive officer, chief operating officer, chief scientific officer for Pfizer, BioEnTech, Moderna and Johnson & Johnson.

**Francis A. Boyle:**

By the way, J & J are the same people who gave us the opioid epidemic killing about 500,000 Americans and also gave us talcum in baby powder.

**Dr. Joseph Mercola:**

Asbestos. Asbestos.

**Francis A. Boyle:**

That was giving women cancer of the ovaries. So my advice again, seek these indictments for murder and conspiracy to commit murder at least against those three individuals at the top of these four companies whose Frankenshots are now in circulation here in the United States.

**Dr. Joseph Mercola:**

So if this strategy is to be effective, it would be wise to empower the people who are doing this request to go with resources. So I've heard you mention in previous interviews that there's a paper you have written that summarizes this strategy, but there's also a recent book that goes into great detail and with many references, is it the-

**Francis A. Boyle:**

Yeah, let me get that book.

**Dr. Joseph Mercola:**

"Search for the Origin of COVID-19" book?

**Francis A. Boyle:**

Well, the one I just read, Markson, "What Really Happened in Wuhan."

**Dr. Joseph Mercola:**

Okay, "What Really Happened-" Okay, there's a few of them out there.

**Francis A. Boyle:**

I think there's another book coming out, I haven't read it yet, but I read through this book and I think she's got it all there. She didn't get the arguments on the – she didn't deal with the Frankenshots, but she has, I

think, a valid summary of all the evidence that has been compiled, I think, so far, involving all these individuals. For the first set of indictments I called for, yes. As for the second, I think Robert Kennedy Jr., his Children's Health Defense, and you've done good work on this too, have compiled-

**Dr. Joseph Mercola:**

[crosstalk 00:34:30] Well, Robert Kennedy-

**Francis A. Boyle:**

-this information the best they can.

**Dr. Joseph Mercola:**

Yeah, and he's written a new book that will be released after our interview gets aired and that is-

**Francis A. Boyle:**

That's correct. I listened to his podcast on the book.

**Dr. Joseph Mercola:**

-Oh, my gosh.

**Francis A. Boyle:**

And it seems to me he's-

**Dr. Joseph Mercola:**

[crosstalk 00:34:48] I've read the entire book. It's-

**Francis A. Boyle:**

-I haven't read the book yet.

**Dr. Joseph Mercola:**

-Yeah, well, it was only given to about a half a dozen people pre-release, so I was fortunate to get it and it's beyond outstanding and is an indictment for Anthony Fauci, and it is hard to imagine how he will not survive this exposure and will result in a resignation. You could tell, Rand Paul interviewed him yesterday, the day before this interview, in Congress and you could just listen to his voice. But even more importantly you can view the hundreds and thousands of comments that were posted on this YouTube video and it was shocking because I didn't see one, not one that didn't agree that Fauci was a villain. And that he should be-

**Francis A. Boyle:**

He should be indicted for murder and conspiracy to commit murder.

**Dr. Joseph Mercola:**

Absolutely.

**Francis A. Boyle:**

[crosstalk 00:35:40] Just speaking as a law professor, right.

**Dr. Joseph Mercola:**

Yeah, he's a sociopath and I mean, he's just-

**Francis A. Boyle:**

He clearly is, yes.

**Dr. Joseph Mercola:**

[crosstalk 00:35:46] So anyway, I think his days are numbered.

**Francis A. Boyle:**

[crosstalk 00:35:49] And I don't have the book yet, I've ordered it and I did listen to RFK Jr.'s podcast on it, but it seems to me there's going to be a lot more evidence from what you're telling me and what he is saying is in there.

**Dr. Joseph Mercola:**

[crosstalk 00:36:04] Oh, there's thousands of references.

**Francis A. Boyle:**

[crosstalk 00:36:06] that will support what I've been saying here, yes.

**Dr. Joseph Mercola:**

Yeah.

**Francis A. Boyle:**

And it can be used to take to your state or local prosecutor to seek the indictments that I have recommended here today for murder and conspiracy to commit murder. Likewise, I also want to point out this, as we know Bill Gates is an investor in BioEnTech.

**Dr. Joseph Mercola:**

Mm-hmm (affirmative).

**Francis A. Boyle:**

Right now, he's been very careful to stand back and stay out of this, but with the development of more information as to what Gate's was involved in, we very well might be able to pursue an indictment for conspiracy to commit murder. But right now, I'm just throwing that out here. Right now, I don't have all that evidence and when the prosecutors convene grand juries, they can subpoena these people and subpoena duces tecum not only show up themselves, but bring whatever evidence they have. Their office files, their emails, et cetera, sure, that can be done. So I'd think Gates needs to be considered, I'm not recommending he be indicted at this time because I haven't seen enough evidence there implicating him, but since he is a well-known investor in BioEnTech, sure.

**Dr. Joseph Mercola:**

Well, Bobby Kennedy goes into detail, great detail in the book with Gates.

**Francis A. Boyle:**

Right, that's my understanding. [crosstalk 00:37:36].

**Dr. Joseph Mercola:**

Even extension to Rockefeller, whose strategy he followed and implemented almost a century later because they had similar paths and they were both vilified massively by the public and had incredibly poor public images until they shifted to philanthropy.

**Francis A. Boyle:**

Well, as we know, The Rockefeller Foundation always supported eugenics.

**Dr. Joseph Mercola:**

Yes.

**Francis A. Boyle:**

And they were working in cahoots with the Nazis. And Doctor, I know the American people are probably going to find this hard to understand, but I've been studying Nazis not only in Harvard Law School, but I have a Ph.D. in political science from Harvard Graduate School of Arts and Sciences, where Harvard produced future professors of political science. I'm afraid what we're seeing here is just this Nazi mentality. It's that simple. You said sociopath, I think it's clearly a Nazi mentality at work here among the highest level officials of this country. And it's really going to be up to the American people to stop this and bring them down at a state and local basis.

**Francis A. Boyle:**

I think that if we can even get one out of 400 local prosecutors to convene a grand jury and return indictments for murder and conspiracy to commit murder, this whole house of cards will collapse.

**Dr. Joseph Mercola:**

Okay, I've got a question with respect to previous strategies that have been implemented successfully and the one that comes out as a glaring example would be the process used to essentially decimate the tobacco industry, which-

**Francis A. Boyle:**

Which industry? Oh, tobacco. Yeah.

**Dr. Joseph Mercola:**

Tobacco. So I mean, they were successfully able to lie to the public on a consistent basis and I can remember and I'm sure you well do, when they had the five CEOs of the major tobacco companies testifying before Congress and every one of them denied that A, tobacco was addictive and then B, tobacco caused lung cancer. It was just shocking that they would do that. But nevertheless, there was a strategy that was deployed where there was a coalition of a large number of state attorney generals who got together and sued the tobacco companies and that's what took them down. They literally were able to levy tens of billions of dollars of fines against them and implement warnings that are to this day on every package of cigarettes. So the reason I'm mentioning that, and I'm sure you're more familiar with the legal details than I am, but is this a similar process that you're suggesting?

**Francis A. Boyle:**

Oh, not at all. First, I think, as you know, that took years to bring down tobacco and fine – we also know now today, yes, many state's attorney generals are filing lawsuits, which it's a good thing, fine. But the problem is they're filing these lawsuits in federal court and as I told you-

**Dr. Joseph Mercola:**

Oh, that's the problem.

**Francis A. Boyle:**

.The federal judiciary, my experience as a licensed attorney and having appeared in federal court since 1982, it's going to be a long time coming, if ever, before we can stop what's going on here and especially stop these Frankenshots from-

**Dr. Joseph Mercola:**

Okay.

**Francis A. Boyle:**

[crosstalk 00:41:03] their objective is to poison everyone in America with these things.

**Dr. Joseph Mercola:**

This is a very, very important detail that literally escaped me, so and I'm sure it escaped most other people, so can you help everyone understand the different processes they're employing? So the regular state attorney generals who are filing these lawsuits, they're filing them in federal courts, and as we – at the beginning of this interview, we both agreed widely or conclusively that, that's not going to be effective because they've been captured. They've been captured completely by the industry, so it's got to go outside of the system. So how does the local prosecutor do this? He just files it in his state or his local jurisdiction they're filing these indictments of the grand juries? [crosstalk 00:41:43]

**Francis A. Boyle:**

Even in his or her own county, right.

**Dr. Joseph Mercola:**

Okay.

**Francis A. Boyle:**

That's it.

**Dr. Joseph Mercola:**

All right, so that's outside the federal system.

**Francis A. Boyle:**

[crosstalk 00:41:47] So that is why I am – and please understand, I'm not criticizing any state attorney generals who are filing these lawsuits, but it's going to take time and regretfully, doctor, it will end up, these lawsuits will end up in the United States Supreme Court.

**Dr. Joseph Mercola:**

Mm-hmm (affirmative).

**Francis A. Boyle:**

And given the current constituency or justices up there, I'm afraid they're going to uphold these things, except from the few decisions that have come down, will permit religious exemptions and medical

exemptions. But at the end of the day, I don't see them stopping the Frankenshots, no, [crosstalk 00:42:36] so that is the dilemma. I applaud the state attorney generals who are now filing these lawsuits, that's great. I guess your governor down there in Florida is involved in this.

**Dr. Joseph Mercola:**

Mm-hmm (affirmative).

**Francis A. Boyle:**

But I'm saying, we cannot rely on the federal courts, including the United States Supreme Court, the American people cannot, to pull our chestnuts out of the fire because I don't think they're going to do it at the end of the day. Look at these articles, these exposés in the Wall Street Journal where you found out well over 130 federal judges were unethically, unethically ruling on cases where they had investments involved. Okay? So I don't really trust the federal judiciary at all to do the right thing here. I don't think the American people should. And you certainly can't trust the current U.S. Supreme Court. As I said, I think they will give a religion exemption and a medical exemption, but all the rest of us will get screwed there at the U.S. Supreme Court.

**Dr. Joseph Mercola:**

Okay. Well, thank you for that clarification because it's really an important distinction. So I have another questions with respect to the funding of the SARS-CoV-2 genetically engineered virus that's been inflicted upon the population, the global population. So you make a very compelling evidence that the United States has supported research and indeed they have. I don't think anyone who is rational could refute that, but the other component is a position that I've come to appreciate from interviewing, a Chinese M.D./Ph.D. Virologist, Li-Meng Yan, and she really had some interesting components because she grew up in that system and she was directly involved with that research. And she actually defected to the United States out of Hong Kong and they've been trying to, she refers to it, “disappear” her ever since for stating her beliefs.

**Dr. Joseph Mercola:**

But her position is that the Chinese were the primary funders of this, that their intention and their desire was to wipe out the United States and the collateral damage to the rest of the world is fine, but their primary target was the United States. And it appears that the United States – because the United States contribution to the funding was relatively small to what the Chinese input is, so I'm wondering if you looked deeply into that and offer any opinions on it.

**Francis A. Boyle:**

I've read her paper, yes. And let me say this, clearly China was research, develop, testing, stockpile, existentially dangerous biological warfare weapons and the Wuhan BSL-4 was their first Fort Detrick. And by the way, the bat queen went to our BSL-4 at Galveston, which I've condemned before, to get training on how to run their BSL-4, their own Fort Detrick. So yes, what happened, Doctor, was this. When the Reagan Administration heavily got into DNA genetically engineering biological warfare weapons, it set off an offensive biological warfare weapons race around the world. I've never worked for the United States government, I've never had a security clearance, I've never had access to classified information. Everything you needed to know was all out there in the public record if you looked at it.

**Francis A. Boyle:**

And so what happened here I believe under President Xi, was that he wanted his own Fort Detrick. He wanted to play with the big boys and yeah, so they put large amounts of money into research,

development, and testing of offensive biological warfare weapons, without a doubt, and COVID-19 was one of them. That's correct. Now, I again, Doctor, disagree with this Chinese scientist. So far I have not seen the evidence that China deliberately unleashed this, I still go along with our original discussion. I believe that this was a leak out of Wuhan BSL-4, the Wuhan complex. All of these BSL-4s leak, every one of them.

**Dr. Joseph Mercola:**

Mm-hmm (affirmative).

**Francis A. Boyle:**

Including our own Fort Detrick and indeed if you are interested, Doctor, there is a video available online, a documentary by Coen and Nadler, "Anthrax War," going through the existential dangers of BSL-3s and BSL-4s. I believe this was 2009. I served as a consultant to them on this, it won awards, and I was in there, and I conclude on the last shot in there and I say, "This is a catastrophe waiting to happen." Okay? The BSL-3s and the BSL-4s is what I was referring to, that they were all involved in research, development, and testing of biological warfare weapons. Well, it happened in China. What can I say? So I have still have not seen the evidence that China deliberately unleashed this.

**Dr. Joseph Mercola:**

Well-

**Francis A. Boyle:**

But I'm keeping my mind open, but I haven't seen it [crosstalk 00:48:30] so right now, I'm dealing with the theory that yes, they were involved. And this was-

**Dr. Joseph Mercola:**

-[crosstalk 00:48:38] The crux of the question wasn't so much if they intentionally released it, that's sort of not relevant to the central issue, which was the primary funder of the research.

**Francis A. Boyle:**

That's correct.

**Dr. Joseph Mercola:**

Her contention was that the Chinese, that China contributed far more than the United States did [crosstalk 00:48:54] because it was their intention. Now, I actually – in my interview, we didn't really... I don't recall really discussing the intentional release versus accidental lab leak.

**Francis A. Boyle:**

Well, I did read her paper on this and that's the only part I disagree with.

**Dr. Joseph Mercola:**

Okay. [crosstalk 00:49:10] 100% of it, but she seemed really sincere and very limited reason to-

**Francis A. Boyle:**

I accepted the rest of her argument, yes.



**Dr. Joseph Mercola:**

Yeah. Yeah. All right, so that's interesting then. So from your perspective and hers, China really had this designed. It wasn't like the U.S. came in there and said, "Let's design this." They were already going for it and they just participated in this research.

**Francis A. Boyle:**

They did.

**Dr. Joseph Mercola:**

Yeah.

**Francis A. Boyle:**

As a matter of fact, the bat queen took this synthetic biological warfare agent with synthetic biology over to the UNC BSL-3 to give it gain-of-function property, so you're right. But of course, Doctor, we do the exact same thing here at Fort Detrick.

**Dr. Joseph Mercola:**

Yeah. Yeah.

**Francis A. Boyle:**

[crosstalk 00:49:59] The Chinese, and the British do it at Porton Down, and the Israelis do it, and the French do it, and the Germans do it. The major military powers are all heavily into developing an offensive biological warfare weapons industry. If you read what has happened here in the United States, it's very similar to what we had before the Biological Weapons Convention. Seymour Myron Hersh had a book about 1968 exposing everyone involved in the U.S. biological warfare weapons industry at that time when technically it was not illegal. That industry has been reestablished here in the United States, the British have it, the French have it, the Germans have it, the Israelis have it. The Israelis are not a party of the Biological Weapons Convention and China has followed lockstep with it, sure.

**Dr. Joseph Mercola:**

Okay, so let's get back to your central thesis and argument, which is your proposal to catalyze a movement to convince a number of the local elected attorney generals and district attorneys to file or make a motion for a grand jury to indict these criminals for the millions of people they killed or will kill. So in my view it seems best not to do that by yourself but to find a few friends in your local community because they can understand that there's a number of people in their community that are interested in this and they'll not just dismiss you as a local crackpot, especially if they're somebody who's bought the media propaganda on this topic.

**Dr. Joseph Mercola:**

So once you find a few people in your area and identify the attorney that is going to be responsible for doing this filing, what process or strategy would you recommend or endorse? How do they even go about finding the responsible individual, because I guess there's several levels, you can do it at the local, the county, and if there's a level above that, the state of course to identify these individuals? And how would they go about beginning the communication and putting together a formal proposal or plan of action?

**Francis A. Boyle:**

Sure. They're on your ballots when you vote. All you have to do is look at who's running for-

**Dr. Joseph Mercola:**

We don't keep our ballots, right? We look at them briefly and forget about them. [crosstalk 00:52:37]

**Francis A. Boyle:**

Right, but you can just call that up on the internet.

**Dr. Joseph Mercola:**

Okay.

**Francis A. Boyle:**

The old ballot, the recent ballot, who were you voting for, that's the beauty of this that you elected these people, and they are accountable to you, and you pay their salaries, and you can dis-elect them if they don't do what you want them to do. So you need a core of people in that community to go in and personally – emails don't do it, between you and me, I'm a lawyer I pay attention to emails, but anything serious I expect to talk face to face, person to person. So you set up a meeting, you go in, you talk to this person, you can bring in the book, you can bring in my lecture that I sent you, you can bring in this video and say, "We want you to convene a grand jury and present this evidence."

**Francis A. Boyle:**

And of course, it will be for the grand jury to decide whether or not to return an indictment for murder and conspiracy to commit murder against anyone. Fine. If the grand jury doesn't return an indictment, well they don't. But the old saying goes, that a prosecutor can get a grand jury to indict a ham sandwich if the prosecutor wants to. So I think the prosecutor then at that point will say, "Okay, I'll look into this," they've got a staff, they can get together the evidence, and convene the grand jury. Indeed, if you are interested, doctor, I'm a political independent. I have been for my entire career because I figured that's the only way I could do this work. The House Minority Intelligence Committee recently produced a report on this and I read through this report, and they have everything in there on the origins of COVID-19, so that is another source.

**Francis A. Boyle:**

Now, maybe a Democratic prosecutor will reject that, but there are a lot of Republican prosecutors around the country who I think would pay attention to this latest House Minority Intelligence Report on the origins of COVID-19 and they have a staff and go out there and dig up the evidence that is clearly out there in the public record, sure. And we'll now have Bobby Kennedy Jr.'s book as well.

**Dr. Joseph Mercola:**

Yeah, you bring up a good point because while this clearly is not a partisan issue, it would seem that the likelihood of success is far higher for those who are – if the attorney they're seeking to convince is a Republican versus a Democrat, or more generically someone who's bought the propaganda, but the percentages of people who bought the propaganda are much higher in the Democratic party than the Republican. I mean, it's very clear. So if you're just going by odds, it seems like you're more likely to be successful in a Red district than a Blue.

**Francis A. Boyle:**

I think you're right on that, yes.

**Dr. Joseph Mercola:**

Yeah, so-

**Francis A. Boyle:**

I mean, our local district attorney here, she's a Democrat, so I don't think she'd really be doing [crosstalk 00:55:57].

**Dr. Joseph Mercola:**

Yeah, well you're in a strong Blue community with Illinois.

**Francis A. Boyle:**

Well, I regret to say our Governor Pritzker, he's gone full Nazi here.

**Dr. Joseph Mercola:**

Yeah. Yeah. And the Chicago mayor is probably even worse [crosstalk 00:56:10].

**Francis A. Boyle:**

[crosstalk 00:56:10] Frankenshots. Right, but you now have – just read the New York Times and Wall Street Journal, the New York Times says there's an Associated Press report this morning I read of all the attorney generals of the states now filing lawsuits in federal court against this. Well, I'm saying fine, those are states that you should also go to your local prosecutors. I don't really see it happening here in my district.

**Dr. Joseph Mercola:**

[crosstalk 00:56:41] Well, let me just walk this back a step because I think it may be effective because you've already got a number of states, I don't know the exact number, but I believe it's more than 20, if not it's very close to 20, that have filed these lawsuits in a federal court. Wouldn't it make sense to parallel process and multitask and also file it in their own jurisdiction outside of the federal bureaucracy?

**Francis A. Boyle:**

Doctor, that could be done too, but I think if you're going to do something at a state and local basis, it should be to go for the indictments for murder and conspiracy to commit murder.

**Dr. Joseph Mercola:**

Yeah, I agree but-

**Francis A. Boyle:**

[crosstalk 00:57:20] That will really get everyone's attention.

**Dr. Joseph Mercola:**

Wouldn't it make more sense to hit the state attorney generals that are already convinced to also apply this strategy and do it locally with the understanding that it's highly likely they're going to be roadblocked by the federal system?

**Francis A. Boyle:**

Well, the problem here is that the OSHA (Occupational Safety and Health Administration) regulations that Biden just put out, they're taking the position that federal law will supersede state law in this whole area and that is a problem you have under the 6th Amendment to the Constitution, suing-

**Dr. Joseph Mercola:**

[crosstalk 00:58:05] Well, that's for the mandates, but it doesn't apply to the grand jury indictments for murder.

**Francis A. Boyle:**

No, of course not. No, so that's what I'm saying at the state and local level, I think the best thing-

**Dr. Joseph Mercola:**

Yeah, I agree. [crosstalk 00:58:18] But that's what I'm saying, that the attorney generals who are filing these lawsuits in the federal judiciary, in the federal law system, shouldn't they concurrently file in their own state these indictments or the-

**Francis A. Boyle:**

They should pursue. You don't-

**Dr. Joseph Mercola:**

[crosstalk 00:58:34] Yeah, that would be a no brainer because they're already on board.

**Francis A. Boyle:**

-file indictments. Right. Technically you don't – I misunderstood what you were saying. Technically you don't file indictments, you [crosstalk 00:58:45] seek an indictment for a grand jury. Yes.

**Dr. Joseph Mercola:**

Right.

**Francis A. Boyle:**

They should do that, yes. They all should.

**Dr. Joseph Mercola:**

Okay. So it would seem to me, if you're in one of those lucky states where the state attorney general has filed the lawsuit for the mandate, then that attorney general is ripe for harvesting and to convince him to call a grand jury to indict these criminals for murder.

**Francis A. Boyle:**

That's right, but I don't live in one of those states unfortunately.

**Dr. Joseph Mercola:**

Yeah, but a lot of our viewers do.

**Francis A. Boyle:**

They do and that would be my advice, yes.

**Dr. Joseph Mercola:**

That could be a ticket because you've already got 20 high-level state attorneys or maybe more, I just don't know the number, I can't recall, that they're on board with this. But these are the guys who would be up for convening a grand jury in their own state.

**Francis A. Boyle:**

That's correct.

**Dr. Joseph Mercola:**

Outside the system. Yes! That is a winning strategy.

**Francis A. Boyle:**

Yes.

**Dr. Joseph Mercola:**

All right, I'm glad we solved this problem.

**Francis A. Boyle:**

Well, we've started to solve it. What can I say?

**Dr. Joseph Mercola:**

Yeah, I know, but it's just-

**Francis A. Boyle:**

But I think-

**Dr. Joseph Mercola:**

[crosstalk 00:59:45] you've got to work out the details because the implementation is so important and if you have someone in a strongly Democratic jurisdiction and they're trying to get their local county DA, district attorney, to file something, it ain't going to happen.

**Francis A. Boyle:**

Right. I don't think so.

**Dr. Joseph Mercola:**

So you've got to be – you've got to limit, everyone has limited resources, time being the most significant, but you've got essentially an opportunity, it's a massive opportunity and we'll identify the specific states when we write this article so it'll be in there.

**Francis A. Boyle:**

Right.

**Dr. Joseph Mercola:**

And give people and encourage people in those states to catalyze this process because I think it's really important.

**Francis A. Boyle:**

Right. That's why I'm appearing here today with you, I guess for the past hour, to articulate this in language that common, ordinary, everyday Americans can understand. I've tried to stay out of a lot of legalese or anything like that. And I have had to use a few legal terms, but I think it all could be understood.

**Dr. Joseph Mercola:**

I'm suspicious that you would be open and willing to serve as a consultant to those who are willing, or not willing, but are successful in engaging with the state attorney generals to file or to issue these calls for convening the grand juries if they need it.

**Francis A. Boyle:**

[crosstalk 01:01:07] Right, I've been asked for help on this matter ever since I first blew the whistle January 24th, 2020 that COVID-19 was an offensive biological warfare weapon leaked out of that Wuhan BSL-4. And all BSL-3s and BSL-4s around the world need to be immediately shut down. You'll see, Doctor, they're already talking about the next pandemic, right?

**Dr. Joseph Mercola:**

I'm sure.

**Francis A. Boyle:**

Where's the next pandemic going to come from? Their own BSL-3s, and their BSL-4s, and their offensive biological warfare program that have been in operation under Fauci and Reagan. That's how far back, that's where the next pandemic is coming from and we have to shut down all these BSL-3s and BSL-4s immediately. Yes.

**Dr. Joseph Mercola:**

Yeah, that is a big step. We've got some other bigger ones, I think, before then though like stopping the killing of the majority of the United States population.

**Francis A. Boyle:**

I agree with you on that too.

**Dr. Joseph Mercola:**

Yeah, because it's like a one-two punch. I mean, we're going to be – even if it doesn't kill you, it's permanently impairing your immune response, making you far more susceptible future exposures to these pernicious lab engineered viruses. So they're weakening your system.

**Francis A. Boyle:**

As I told you on the Gulf War Frankenshots, one-fifth disability and they were far less dangerous than what we're dealing with here. That's correct.

**Dr. Joseph Mercola:**

Yeah. Well, so it's – I think it's encouraging. There is a reasonable, rational strategy that don't think would require a lot of time and effort, certainly some to go forward and meet with these – I mean, you provided the outline for it, but really another important component is to meet with these attorneys in person.

**Francis A. Boyle:**

Right.

**Dr. Joseph Mercola:**

This is not an email campaign folks.

**Francis A. Boyle:**

No.

**Dr. Joseph Mercola:**

You need to connect with them personally and hopefully identify individuals in your local community who are very eloquent, articulate and knowledgeable about the facts because otherwise they're going to dismiss you easily, even though you're right.

**Francis A. Boyle:**

Right.

**Dr. Joseph Mercola:**

So you need to have an eloquent communicator on your team.

**Francis A. Boyle:**

Right.

**Dr. Joseph Mercola:**

That can engage in the dialogue. So I think this is a reasonably good strategy and I thank you for coming up with it. But it takes guys like you to figure this thing out.

**Francis A. Boyle:**

Well, thank you very much for having me on. My best to your audience here.

**Dr. Joseph Mercola:**

Okay, any other words of wisdom you'd like to share with us?

**Francis A. Boyle:**

Well, I think I've given everything I can, except we have to act immediately, as soon as possible to stop this Nazi insanity that is being imposed on the American people by the Biden Administration.

**Dr. Joseph Mercola:**

Yeah.

**Francis A. Boyle:**

And they know what they're doing there. Biden's Chief of Staff, Ron Klain, was behind me at Harvard Law School and he was President Obama's Ebola Czar, and Obama too was behind me at Harvard Law School. All right, and Klain personally handled the coverup of the fact that the black West African Ebola pandemic started out by the testing of experimental Ebola vaccines in violation of the Nuremberg Code of

So thank you for helping provide a rational practical strategy that seems to have great potential for making a dent in the craziness that we're going through.

**Francis A. Boyle:**

Well, thanks and please keep up your good work, especially now having me on three times to try to explain to the American people what is really going on here.

**Dr. Joseph Mercola:**

[crosstalk 01:05:57] Well, you did successfully the first time. This is one of the first major interviews that got out there exposing the fraud. I mean, literally it was one of the first. I know you had been on other shows before, but we have a bigger reach. I mean, we go to like 30 million people a month, so that's a pretty significant penetration.

**Francis A. Boyle:**

Right.

**Dr. Joseph Mercola:**

So a lot of people are going to hear this message, I can assure you.

**Francis A. Boyle:**

Good.

**Dr. Joseph Mercola:**

All right. Well, thanks for all your efforts.

**Francis A. Boyle:**

All right, thank you, doctor, you keep up the good work too.

**Dr. Joseph Mercola:**

All right, thanks.

**Francis A. Boyle:**

Bye-bye.
